Our Legislative Agenda is developed by the Public Policy Committee and communicates the Chamber's positions on issues at the state, local and federal levels of government. Working together with various legislative organizations helps promote public policy decisions that reflect the priorities of the Independence business economy. Below is our stance on our economy's pressing issues, as of January 2024.

Continue to support full funding of Pre-K education and the A+ program through the foundation model.		★

Transformation from Local Kid to Chamber Hero

It doesn't take long to discover in a conversation with Kenny Soule, his business desire is about "taking care of the little guys". I enjoyed a fabulous conversation with Kenny, who holds a strong business presence in our city, but is also a great contributor to the Independence Chamber of Commerce.

Sonci Bleckinger is the lady to which we owe our gratitude for introducing Kenny to the Chamber. Although, Kenny points out, they were schoolmates at Mill Creek Elementary School, in the Independence School District.

Kenny graduated from St. Mary's High School, he participated in football and baseball, but wrestling was his love. He was a talented wrestler which earned him a scholarship to SMSU (now MO State University, Springfield, MO). The SMSU wrestling program, was discontinued, before Kenny had completed college, thus returning to his hometown and working for his dad, Herb Soule, a general contractor.

Physical labor wasn't new to Kenny, as from the age of eight, he carried shingles at construction sites for his dad and granddad. Kenny had learned many important skills associated with the construction business over the years. His brother, Joe (now deceased) and Kenny started working construction together with KJ Remodeling in 1998. Krete Construction was started in 2009.



However, those two businesses have not defined the career life of Kenny Soule. He was a carpenter's apprentice from 2002 to 2007 where he obtained a Journeyman's certificate. In 2010, he attended the MCC Blue River Fire serving the public as a fireman in Sugar Creek for seven years, when he was medically retired from a shoulder injury experienced in a fire.

Overtime, Kenny has brought others into business with him. A friend from childhood, Danny Gervy, who operates the concrete crews. Jake Robbins has partnered with Kenny in the creation of Asphaltic Surfaces, which will be entering their sixth year of business in 2024.

At the invitation of his friend, Sonci, Kenny came to his first Chamber meeting, as the man he is...construction shirt, jeans and work boots, which was different than usual Chamber attire. However, we are the benefactors of Kenny's coming to the meetings and then at a December luncheon, Kenny and his sister, Katie (who is an important associate in Kenny's businesses) felt the Spirit of Christmas in the choir performing that day, and saw the Chamber from that point on as a part of his "family of partners"!

Kenny was particularly helpful to the SantaCaliGon volunteers when he brought his construction crews to clean up all the chairs, tables and other accumulated materials from the Main Stage. Instead of taking most of a day of heavy physical labor for a few SCG volunteers, Kenny and his crew managed to clear all the area in a matter of hours. You can also find Kenny working with Jonathan Zerr at the Main Stage Beer Garden.

Kenny shares the credit for any success he has with his family: Wife, Jana, to whom he has been married 26 years and his two daughters, Marissa and Samantha. He is also devoted to his "family and friends", who have joined with him to create his businesses. Kenny has the internal desire to conduct his business with integrity and to follow the tenets of his faith in doing the right thing for others. His personal goals are to be a good person, as well as demonstrate his Christian tenets in all that he does. He feels strongly that those who are a part of his businesses, should have the same opportunities as he has enjoyed.

On a personal note, anyone who has any interaction with me for long, knows I am passionate about the City of Independence. I came to Independence over fifty years ago, as a teacher. Palmer Junior High School is the place I fell in love with this community and the families and students I met here. Those same wonderful individuals and students, are now some of the leaders of Independence. The youth are a tremendous asset to any community...like Kenny Soule! How blessed this community and this Chamber have been by having so many wonderful caring individuals, who spend much of their time making our city a finer place to live, work and play!

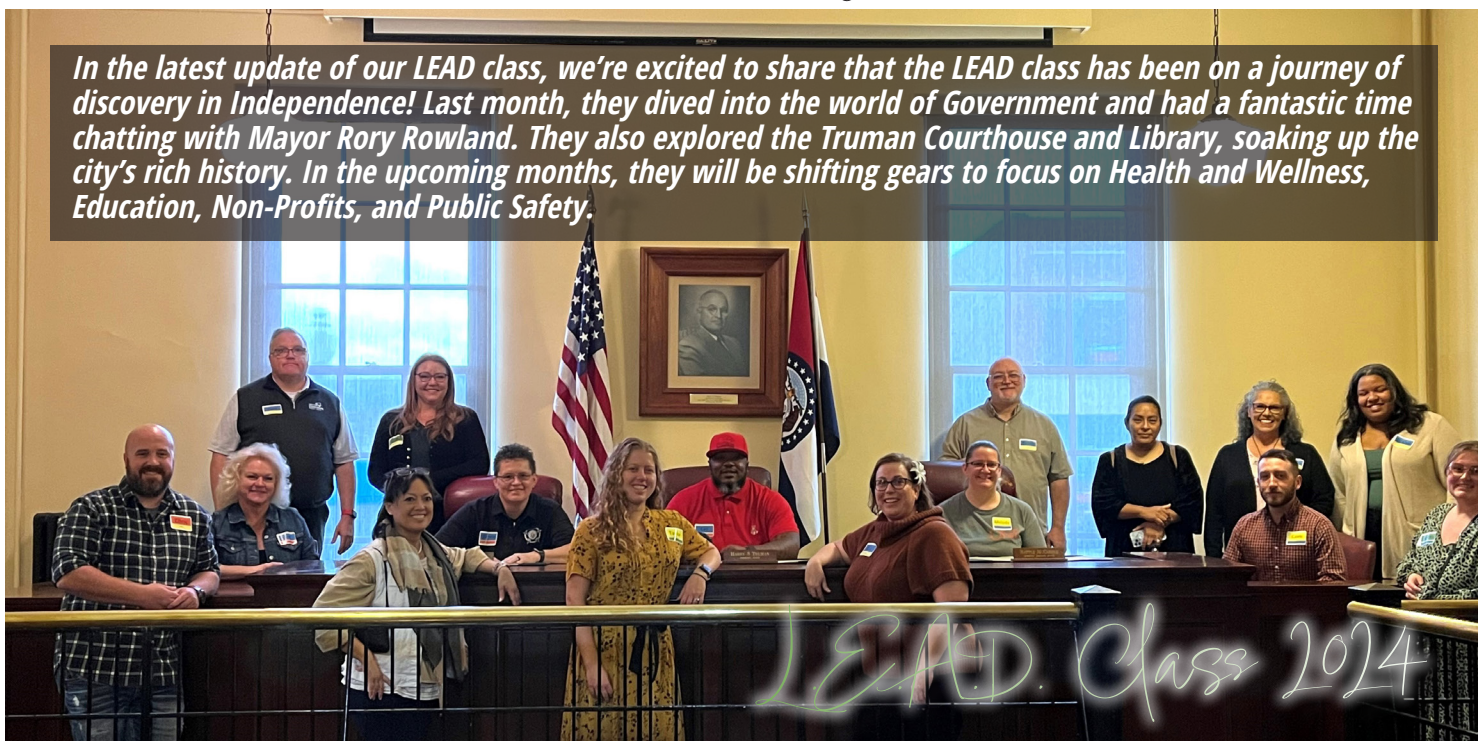
